Hibbing Foundation is proud to be featured in Minnesota Community Foundation's 2006 Annual Report: The State of Philanthropy

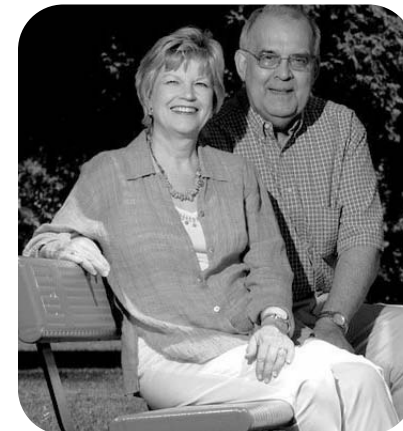
In Hibbing, great leadership means great things for the community. The Hibbing Foundation raised more than \$1 million in 2006 through the efforts of a well-respected board of directors, an energetic executive director and the examples set by local residents who have converted their private foundations into Donor Advised Funds.

Although the foundation was established in 1993, much of its growth has occurred in the last few years. "In a town this size, people pay close attention to what you're doing," explains Hibbing Foundation Executive Director Jennifer Hoffman. "We had to prove ourselves over time by making good, solid grants; our association with the Minnesota Community Foundation has also given us credibility. We've gained enough momentum that people are now coming to us rather than our having to reach out to them."

Less work, more reward

Hoffman credits Hibbing natives Ted and Sherry Spanner and Dr. Ben Owens with paving the way for inquiries from fellow residents when they converted their private family foundations into Donor Advised Funds of the Hibbing Foundation.

The Spanners focus mainly on education-related grants (their family foundation helped more than 175 students attend college). "When we set up our family foundation in

the early 80s, doing so privately was really the only option," says Ted Spanner. "That took a fair amount of time and money. But as we became familiar with the Foundation, we realized that we could eliminate ongoing costs and benefit from professional management of our funds while

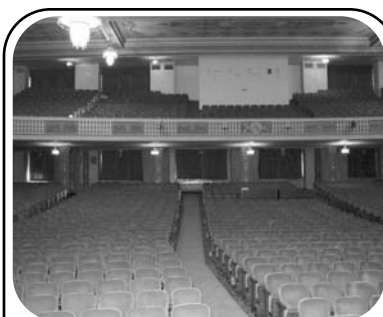
